ORDER AND DECREE DECLARING THE ORGANIZATION AND		
FORMATION OF THE ARKANSAS VALLEY AMBULANCE DISTRICT		

THIS MATTER COMES ON a Motion by the Petitioners for a Court Order and Decree declaring that the Arkansas Valley Ambulance District is hereby organized as a special district.

Based on the Court file and the Motion (along with the accompanying Certificate of Election from the Fremont County Clerk and Recorder), the Court hereby FINDS:

- 1. The Petitioners have previously filed a Petition with the Court requesting formation of the Arkansas Valley Ambulance District, and such Petition was previously determined by the Court to be sufficient.
- 2. The Court thereafter held a hearing, for which notice was appropriately provided pursuant to C.R.S. § 32-1-304.
- 3. Following the hearing, the Court found that the petition for the organization of the Arkansas Valley Ambulance District had been signed and presented in conformity with part 3 of Article 1, Title 32, C.R.S., and that the allegations of the petition were true.
- 4. The Court then ordered that an election be held at the November 2018 general election submitting the question of organization of the special district to the eligible voters of the proposed district.
- 5. Such election was held, and the Court finds that a majority of the votes cast at said election was in favor of the organization of the District.
- 6. The Court further finds that such election was held in accordance with articles 1 to 13.5 of Title 1, C.R.S.

## THEREFORE, THE COURT HEREBY ORDERS AND DECREES:

7. The Arkansas Valley Ambulance District is hereby organized, and given the same name.

- 8. In all proceedings, the District shall be known as the Arkansas Valley Ambulance District.
- 9. The District shall be a quasi-municipal corporation and a political subdivision of the State of Colorado, with all the powers thereof conferred by statute.
- 10. The following are hereby declared elected as the first Board of Directors of the District:
  - a. Four-Year Terms:
    - i. Thomas Kainz
    - ii. Nicole Lewis
    - iii. Andra Dolton
  - b. Two-Year Terms:
    - i. Jordan Clewell
    - ii. David Van Nattan
- 11. The District shall provide all notices and file copies of this Decree as required by statute, including as required by C.R.S. § 32-1-306.
